

ourselves in contentious organizing campaigns on the badly-sited Slover Distribution warehouse in Bloomington and the Flying J truck stop near Mira Loma Village in Jurupa Valley. We also started organizing deeply around AB617, as San Bernardino was selected as a priority community.

**Organizing the Community:**

In 2018, we dove deeply into organizing our communities. We were constantly in community spaces and in community members' homes, schools and churches throughout our priority communities in San Bernardino, Bloomington and Jurupa Valley. We educated and agitated community around the issues surrounding air pollution and encroaching industrial projects proposed to be built right next to our neighborhoods. Through various community meetings and 1-1 meetings with community leaders, we engaged 605 community members.

**Leadership Development:**

From organizing to development, in 2018 we devoted a significant amount of our organizing work on training community on an array of topics, from learning the science behind air pollution to maneuvering that knowledge on committees and boards. In total, we were able to engage 234 community members to participate in community training sessions. We are expecting to raise these numbers in 2019 as we expect to make this a greater priority by being more intentional on the leadership development component and by reintroducing computer literacy classes into the community.

**Taking Action:**

With a base ready to defend their communities against polluters, our

organizing program led us to take a series of actions. We took action in a multitude of ways in 2018, ranging from protests outside legislators' houses, attending public hearings, holding community events on air pollution, writing handwritten comment letters to decision-makers and visiting our public officials. 2018 was a very busy year, as we held or co-supported community events and turned out 484 community members in total to these events. Continuing with the same level of action, we were also able to turn out over 212 community members to public hearings in 2018 and another 53 to participate in educating their public officials on our issues. In total, we had 749 community members take action in 2018.

Communications Program

We empower communities through raising the stories from the frontlines and into the mainstream through mediums such as television coverage, newspaper coverage, digital coverage and social media. Our goal is to highlight and lift up the voices of our communities who would otherwise be limited on how and where their stories are told.

Our 2018 Earned Media Hits at a Glance:

In 2018, we were able to work our way to earning 171 media hits. That level of exposure is comparable to the success large non-profits have. The first chart shows our earned media hits throughout the year. Anthony was hired in May, and the increase in earned media is significant. The second chart shows our 2017 performance against our 2018 performance. In 2017, we were able to garner 87 media hits, compared to 171 in 2018, signifying a 49% increase in earned media hits.

Our 2018 Instagram at a Glance: In 2018, we created and launched the CCAEJ Instagram account. Since its launch in May 2018, we have been posting original content at an average of 27 posts a month, which is almost 1 daily post. Traffic to our page and engagement with our page has been a huge success, as we average 1,070 views and likes per month.

#### 2018 Twitter at a Glance:

In 2018, we revived our Twitter account. The first 4 months of 2018, we were averaging 17 Tweets per months, with our followers engaging with us at an average monthly rate of 20 Retweets and 65.5 Likes. When Anthony took over in May, we saw our averages go up to 39 Tweets, 182 Retweets and 350 Likes monthly. When compared to 2017 Twitter metrics on Tweets, Retweets and Likes, we had a significant increase in both posting and engagement from our followers. The second chart below shows that in 2018, we averaged 32 Tweets per month, compared to 21 Tweets monthly in 2017, an increase of 34%.

#### Our 2018 Facebook at a Glance:

In 2018, we continued to improve the pace of the prior year for our Facebook page. Facebook Posting and Interactions from followers was consistent in 2017 and our job in 2018 was to build upon that. Our goal to improve and increase from 2017 to 2018 was a success across all sectors. As illustrated in the first chart, in 2018, we posted an average 34 Posts monthly, compared to 24 Posts monthly in 2017, an increase of 29%. As far as engagement in 2018, as seen in the second graph, our followers shared our Posts an average of 105 times per month, compared to a monthly average of 61 Shares in 2017, an increase of 42%. The third graph shows our engagement also increased in the form of Interactions, as 2018 saw an average of 398 monthly, compared to 286
